



Asset Size	Policy Limit	Claim Details	Claim Cost
\$1B	\$3M	Multiple business inbox compromised and used to send a cascading attack of phishing emails out to contact lists. User names and passwords were compromised despite the implementation of multi-factor authentication. Matter remains open for potential third party civil litigation.	TOTAL COST: \$160,000
\$1B	\$3M	Third party managed security provider compromised resulting in large amount of member information compromised. Notification provided to multiple regulatory agencies which have opened investigations.	TOTAL COST: \$105,000
\$3B	\$2M	Corporate Inbox Compromise event suspected to be arising out of an attempt to deploy ransomware onto the system which was unsuccessful. Large amount of affected membership resulting in wide notification and credit monitoring. Multiple regulatory agencies notified with open investigations pending.	TOTAL COST: \$443,837
\$1B	\$1M	Credit union attacked by RANSOMWARE named "MAZE." Software encrypted an entire year of back up information. Demand was in excess of \$4,000,000.	TOTAL COST: \$2,500,000+ Ransom was negotiated down to a little over \$2M.
\$3B	\$2M	E-MAIL INBOX of credit union executive was COMPROMISED. 290,000+ total individuals were compromised. Multiple attorney general inquiries are open.	CURRENT COST: \$650,000 Expected to reach \$1M
\$76M	\$1M	"Trickbot" MALWARE TROJAN discovered on credit union's network. Trojan believed active for a few months before discovery.	CURRENT COST: \$100,000 Expected to rise
\$181M	\$1M	Credit union attacked by RANSOMWARE named "blackmatrix." Initial demand was \$1.5M. Approx. 25,000 members received notification letters for credit monitoring.	TOTAL COST: \$150,000
\$62M	\$1M	An employee's E-MAIL ACCOUNT was COMPROMISED and used to send a fraudulent wire request. 360 individuals received notification letters for credit monitoring.	TOTAL COST: \$34,000


